

RAC Exam Expenses Reimbursement Instructions

SDRAN will offer Educational Awards to 2024 RAC Study Session registrants who pass the Summer 2024, Autumn 2024, and Spring 2025 RAC Devices or Drugs exam. The award eligibility and conditions are as follows:

- Applicants must be SDRAN members when submitting the 2024 RAC Educational Award application.
- Applicants must register for the 2024 Devices or Drugs RAC Preparatory Sessions and pass either the Summer 2024, Autumn 2024, and Spring 2025 RAC exam.
- Applicants must submit a complete 2024 RAC Educational Award application with documentation showing their passing grades in either the Summer 2024, Autumn 2024, or Spring 2025 RAC exam and all eligible RAC exam expense receipts.
- Applicants must not receive payment or reimbursement from their employers or other professional organization for those expenses to be reimbursed by SDRAN.
- <u>Applicants passing the Summer 2024 RAC exam must submit their reimbursement</u> <u>applications (page 2) no later than 20 October 2024.</u>
- <u>Applicants passing the Autumn 2021 RAC exam must submit their</u> reimbursement applications (page 2) no later than 10 February 2025.
- <u>Applicants pass the Spring 2022 RAC exam must submit their reimbursement</u> <u>applications (page 2) no later than 30 June 2025.</u>
- SDRAN will reimburse for the RAPS exam fee (Summer 2024, Autumn 2024, or Spring 2025 exam), RAPS study guide (eg, Fundamentals book), and/or RAPS practice exam up to a total of **\$700.00**.
- SDRAN and/or RAPS membership fees will not be reimbursed.

• <u>2024 RAC Educational Awards are on a first come first served basis</u>. These awards are limited to 4 recipients (2 from the Devices, and 2 from the Drugs Preparatory Sessions) from the Summer 2024 RAC exam; 4 recipients (2 from the Devices, and 2 from the Drugs Preparatory Sessions) from the Autumn 2024 RAC exam; and 4 recipients (2 from the Devices, and 2 from the Drugs Preparatory Sessions) from the Spring 2025 RAC exam. Recipients of the 2021 RAC Educational Award are selected by SDRAN based upon applicants meeting the award conditions and eligibility requirements as well as the earliest date the 2024 RAC Educational Award application is received.
